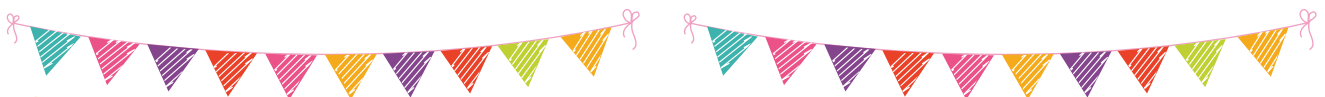
## Father's Day Gift Shop

# PSA ANNUAL GENERAL MEETING

**URGENT** - We need a Treasurer as the current committee member will no longer have a child at the school and the PSA cannot continue to exist/function without one.

The Treasurer ensures accurate financial records are kept, and that best practice procedures are followed for counting money, banking, and making payments. They should keep your committee updated with regular reports, and ensure end-of-year reports are completed for the association's AGM and our Charity Commission's annual return. The current treasurer will be able to do a handover and advise/signpost too.

## Key skills -

- Basic understanding of bookkeeping
- Organised with an eye for detail
- Calm, approachable, and a team player

You would also need to complete a Trustee Eligibility Declaration and cannot act as a trustee if you are disqualified under the Charities Act, inc. if you:

- Have an unspent conviction for an offence involving dishonesty or deception (such as fraud);
- Are bankrupt or have entered into a formal arrangement (for example, an individual voluntary arrangement) with a creditor;
- Have been removed as a company director or charity trustee because of wrongdoing

Whilst the other three Committee Members/Trustees - Chair, Vice-Chair and Secretary - have all confirmed that they are willing to stay on for one further year, you can also nominate/self-nominate for the these roles - same eligibility as above.
